## **IAAMJV Financial Update**

### **Significant Expansion in Loan Scholarship Budget (LSGI, CEL, LSUI)**

The Loan Scholarship programs have experienced remarkable growth, driven by an increasing number of students from India pursuing higher education and a surge in loan scholarship applications. Additionally, the rising cost of education has underscored the need for greater financial assistance.

To meet this demand, IAAMJV significantly increased its loan scholarship budget in 2023 and further in 2024. This expansion has been made possible by generous contributions from the Jain community in the USA and the dedicated efforts of the Loan Scholarship Committee in reviewing and managing applications.

#### **Key Highlights of 2024 Loan Scholarship Expansions:**

- **LSGI Program:**
  - Loan amount increased to \$5,000 per student
  - Student recipients grew from 43 in 2022 to 78 in 2024
  - Total loan disbursement to \$390,000
- **CEL Program:**
  - Loan scholarship amount increased to \$10,000 in recent years
  - The number of student recipients residing in the USA has grown in 2024
- **LSUI Program (for Students studying in India):**
  - Increased outreach efforts have resulted in 175 students receiving support, including 29 students from 11th and 12th grade
  - Minimum loan amount raised from ₹15,000 to ₹20,000, with most loans increasing to ₹35,000
  - Scholarships of ₹50,000 each awarded to 27 students recommended by donors

### TAX SAVINGS STRATEGIES & CHARITABLE GIVING

IAAMJV is a registered 501(c) (3) non-profit tax-exempt organization under IRS regulations.

U.S. tax laws provide significant benefits for charitable giving, allowing individuals to maximize tax deductions while supporting causes they care about. **These strategies can benefit both your family's financial future and charitable organizations like IAAMJV.**

Below are three strategies for your consideration:

#### 1. Donating Appreciated Stock & Mutual Fund to IAAMJV

By donating appreciated assets that you've held for more than a year, you can save on capital gains taxes (and potentially the net investment income tax too). At the same time, you can deduct the full market value of the gift, subject to certain annual limits. Charitable gain harvesting is a valuable tool that allows you to maximize your resources, so that you can fully realize your charitable vision and legacy.

Giving a long-held investment that has risen sharply in value can produce far greater tax savings than an equivalent donation of cash. This shows the difference between donating cash and donating \$50,000 worth of stock for which you paid \$10,000.

If you donate stocks or other appreciated assets held for over a year, you can produce far greater tax savings than an equivalent donation of cash as listed below.



- ✓ Avoid capital gains taxes (including net investment income tax)
- ✓ Claim a full market value deduction, subject to IRS limits
- ✓ Maximize your charitable impact while reducing tax liability

The example below is general in nature and special rules may apply to your specific situation.

Description	Donating \$50,000 in Cash	Donating \$50,000 in Appreciated Stock & Mutual Fund
Value of tax deduction	\$17,500	\$17,500
Tax benefit by donating appreciated stock & Mutual Fund	--	\$9,520
Total tax benefit	\$17,500	\$27,020

**Assumptions:** (1) Donation of \$50,000 in cash vs. donate \$50,000 in appreciated stock with an adjusted cost basis of \$10,000, so a \$40,000 taxable gain, assuming the stock was held for more than one year (2) Income tax bracket: 35% ordinary income tax rate, 20% long-term capital gains tax rate + 3.8% net investment income tax (3) No Adjustable Gross Income (AGI) limits on deduction if it is below 30% of AGI.

If you are not ready to make a charitable gift from your assets/stock at that exact moment, combining charitable gain harvesting with a contribution to a **Donor-Advised Fund (DAF)**. You get an immediate charitable deduction for your donation, and the funds will be available for you to donate at whatever amount and timing you choose.

### 2. Tax Efficient Way of Donating IRA Required Minimum Distribution (RMD)

If you are age 73 or older and own an IRA, you can make qualified charitable distributions (QCD) up to \$100,000 (\$200,000 for married couples who each qualify separately) to IAAMJV from Traditional IRAs without having to pay federal income taxes on the distributions. This amount is indexed for inflation and will be \$108,000.00 in 2025. These distributions are not tax deductible and must be made payable directly to a qualified charity such as IAAMJV.

Please consult your tax advisor or accountant to discuss any tax related implications for executing these strategies.

### 3. Name IAAMJV as a Beneficiary

The death and taxes are inevitable. As we are all aging, this may be a good time to name IAAMJV as a beneficiary **in your will to distribute a portion of your IRA and/or Personal assets**. This will save you ordinary as well as capital gains and estate taxes and help you support the noble cause of education IAAMJV stands for. **We will be more than glad to work with your attorney and provide the details.**

Giving money to a charity is easy for some and very difficult for others. Since none of us take our wealth to heaven, we all need to think very hard and make a conscious decision to donate and change the lives of the bright and needy to brighten their future. Please remember education is the key to success and prosperity. We achieved a huge success due to higher education we received. Let us use this magical formula for others. This is the best way to pay back to the community and make our life worthwhile.

- 2 Loans to undergraduate students who are US-born or on student visas attending any US college for undergraduate studies (CEL program) every five years
- 3 Loans to graduate students coming to the USA to pursue a Master's degree or other higher studies (LSGI program) every year

This scheme allows the Benefactor to perpetually sponsor so many bright and needy Jain students of any sect in your name or your loved one's name, passing on your legacy for generations to come. IAAMJV will provide the Benefactor with the names of all students who receive assistance from this donation and will publish this information in the IAAMJV's Newsletters.

**Donation Amount: \$125,000 in one lump sum or yearly installments of \$25,000 or more**

**Note: The donations made after 2012 for IAAMJV's Loan Scholarship programs can be credited towards the \$125K to enjoy the benefits outlined above. It's a great way to upgrade your current donor status to Benefactor donor.**



### A. Loan Scholarship for Graduate Study in USA for Indian Students coming from India (LSGI Program)

This loan is awarded to students enrolled in graduate or higher studies in any USA institution. A strict selection criterion is applied to all LSGI applications during the selection process. With tremendous support from our donors, we budgeted a loan of \$5,000 each to a total of 70 (+/-) students this year, spread between Fall & Spring semesters which is applicable for three LSGI programs described below.

- **Gold Patron (GoP) Fund Donation for \$20,000:** Under this scheme, every year starting the fall or spring semester, for each LSGI Endowment fund USA a loan award of \$5,000 is made to a qualified student on donor's name. The student is selected by the LSGI Committee. Recipient students' as well as donor's names are published in the IAAMJV's newsletter. Once the recipient starts returning the loan, the amount is re-circulated for future loan awards under the donor's name.
- **LSGI Endowment Fund USA (EF USA) for \$50,000:** Under this scheme, every year starting fall or spring semester, for each LSGI Endowment Fund USA a loan award of \$5,000 is made to a qualified student on the donor's name. Recipient students' as well as donor's names are published in the IAAMJV's newsletter. The selection of the student is carried out by LSGI selection committee with strict criterion. The repayment is merged with the General fund.
- **LSGI - Loan Scholarship from General Fund:** As required, the Loan scholarship is awarded from the general fund which is built up with the donation (any amount) received under the general fund.

### B. College Education Loan Scholarship for Undergraduate Studies for US Students (CEL Program)

The College Education Loan (CEL) program provides interest-free loans to students pursuing undergraduate or associate degrees at any U.S. institution. Each loan is valued at \$10,000, disbursed over a 3-year period.

Under this scheme, a loan is awarded each Fall to a deserving student in the name of the donor for every CEL Fund. The recipient receives \$5,000 in the first year, \$3,000 in the second year, and \$2,000 in the third year. For students applying later in their academic journey (third year or with two years remaining), a reduced loan amount of \$5,000 to \$8,000 is awarded.

Thanks to the generous support of the Jain Community in the USA.

The CEL Committee carefully selects recipients through a thorough evaluation process. The names of both the recipients and donors are published in the IAAMJV newsletter as a way to honor their participation and contribution to the program.

### C. Loan Scholarship for Undergraduate Study in India (LSUI) for Indian Students (LSUI Program)

We award loan scholarships or scholarships (from General Fund or Endowment Fund/Trust) of Rs. 15,000 to Rs. 50,000 to students in India each year. The program is operated through IAAMJV Trust, Amdavad. We are spreading the message on an ongoing basis to the community to expand the program to benefit more students and also to increase the award amount.

- **Endowment Fund India (EFI) for \$5,000:** Under this scheme, every year in September, from the LSUI Endowment Fund India, a scholarship grant is made to a qualified student on donor's name. The current LSUI scholarship amount is Rs. 25,000 per year during undergraduate and graduate studies, generally



between 3-5 years. The grant scholarship is extended to student of 11th and 12th grade also. Recipient students' as well as donor's names are published in the IAAMJV's Fall newsletter. The donor may recommend one student for the scholarship every year before the deadline of the application. The recommendation must be submitted every year to President or Vice President of IAAMJV, USA only. The student's application will be scrutinized by the IndiaScholarship Committee. Alternatively, the donor may request IAAMJV, USA to select one student from the approved list of students for the loan scholarship to award the scholarship.

For this Endowment Fund India scheme, the donation is also accepted in India in Indian Rupees. For the same, a donation of Rs.500,000 is required to open and activate each Endowment Fund. The applications/processing and other terms and conditions will remain the same as above.

### Loan Scholarships Reports - 2025

#### A. Loan Scholarships to Students from India for Graduate Study in USA (LSGI) - by Arvind Shah & Mahendra Shah

LSGI Scholarship Committee has awarded Loan Scholarships to 17 students during the Spring semester, each \$5,000, totaling \$85,000 for the year 2025. We are very fortunate to increase to \$5,000/- from \$4,000/- in a short period. Since the inception (since the year 1993) of the LSGI program, we have disbursed a total of \$ 2,622,500 to 868 students.

In summary, within last 5 years (2021 to 2025), The IAAMJV - EC committee is gladly stating that we increased our annual LSGI loan budget from \$175,000 (2021 to 2025) to \$400,000 (2023 to 2024) and number of students awarded were increased from 35 to 80 annually. This is only possible due to generous support from the various donors like you and Jain community at large.

## B. College Education Loans to Undergraduate US Resident Students (CEL) – Mukesh Shah

Since its inception from year 2000, the College Education Loan (CEL) program has provided interest-free loans amounting to \$503,000 to 89 undergraduate students. In 2024, 10 new students and 14 continuing students were awarded these loans, empowering them to pursue their academic dreams without the burden of interest.

Each Fall, a loan is awarded in the name of a donor for every CEL Fund, helping students achieve their goals while honoring the donor's contribution.

#### IAAMJV Trust (Amdavad) in India: Expanding Support for Jain Students

### 6. **Joint Treasurer**

- Assist treasurer in preparing financial reports audit and tax returns & coordination with auditors
- Keep full documentation on income/expenses of the association along with treasurer
- Keeps tacks of the loan refunds and coordinate with scholarship committee
- Helps members in special donations such as Life Insurance Policies, Stocks, Bonds, etc.

### 7. **Joint Secretary**

- Assist General Secretary and Scholarship committees
- Maintain all scholarship reports
- Follow up and sends reminders to fund collections



### 8. **Board of Trustee (2 Positions)**

**(Eligibility:** Must have served in IAAMJV Executive Committee or other reputable charity organization for at least four years, Must be a member of IAAMJV, Only one member from a family for the trustee position)

- Monitor Association activities to adhere to its stated purposes
- Long-term planning, providing leadership for raising funds
- Long term well-being of the organization
- Safeguard against misuse of association's assets
- Assist in Conflict Resolution
- Approval of donations to institutions (except for donor-advised SMJV and IAAMJV Trust below an amount specified in the by-laws section)
